WASHINGTON LETTER.

(From Our Regular Correspondent.)

WASHINGTON, October 23rd, 1901.

The Capital city is beginning to take on the activities of "the season" which covers the period of the session of Congress. Social circles are being re-opened, the theaters are in full play and the fall weddings are attracting the never failing interest. The period of official mourning for the dead President is ended and the politicians and lobbyists are assembling and laying the lines of their coming campaigns.

The most talked of event of the past week was the presence of Booker T. Washington, the Southern negro educator at a family dinner with the President at the White House. Southern comment upon the incident has been promptly condemnatory of President Roosevelt for what is considered a significant instance of "social equality". More conservative people are inclined to the view that the President, as any other man, has the right to choose his private guests at his pleasure. But few who know the President really believe that in honoring Mr. Washington as he did he meant to become the exemplar and champion of indiscriminate social equality.

The annual national convention of the devotees of Spiritualism has been in session here the past week, evoking the usual lively debates between the believers in the cult and those who declare it a system of delusion and "fakirisms". Never less the representatives of the faith formed a body of earnest speakers who vied to no uncertain faith in the realities of a spirit world imminent upon our own visible world and whose citizens are yet capable of communicating with sympathetic souls still in the flesh. Occultism of any kind has a fascination for the curious and the convention was largely attended.

A local organization has been formed to promote the building of a fitting McKinley Memorial in this city. There is no purpose in this to interfere with the work of the national commissioners appointed by the President to further the erecting of a worthy memorial to the late President at his old home, Canton, in Ohio. Yet it is difficult to figure out how two such projects, each calling for a couple of millions of dollars, may be expedited simultaneously with success. It is to be hoped, however, that both plans can be carried out in fullest achievement.

Washington is becoming one of the greatest student centers of the nation. The several universities already here and the large number of private and technical schools for both sexes are drawing annually larger contingents of young men and women from all parts of the country. The departments of government are filled with young men, brought by Congressmen from their districts, whose chief purpose is to hold office until while fitting themselves to the high classes of the colleges for to have professional careers. There are over three thousand such students in the city at the present time.

The announcement that General Miles, the head of the Army, will report in favor of the law abolishing the wine and beer rations from the army establishments, has produced a sensation in the present camp. The beer dealers are especially disappointed over the report and fear the influence of it upon Congress. An effort is to be made this winter to secure the repeal of the prohibitory law, but it is not likely to succeed. A Congressional investigation will precede any legislation on the subject and that inquiry may develop facts that will support the law and convince Congress that the prohibition is a wise measure for the Army.

for engineers from Wilket's Point, New York, to Washington Barracks, in this city, has been effected. One of the best modern schools of army engineering in the world is to be equipped for the training of our engineering corps. This is one of the most important branches of the military service and the honor men who graduate from West Point are assigned to it as a special mark of merit. With our new possessions that must be occupied and their reconstruction on our level of civilization, largely directed by our army officials, the engineering school becomes a doubly important institution.

At the White House there has been a great coming and going of public men during the past week. The President has been seeking the views of many leaders of his party concerning the topics of his first message and the legislation that should be most urgently stressed in the immediate future. Those of the leaders who were first appointed by President McKinley are facing the legal expirations of their terms and are most of them coming out to seek their reappointments, while those who wish to supplant them are no less in evidence. Between the two and with Congress just ahead, the President is beginning to realize that being a President is not all "biscuits and bouquets".

The return of Ambassador Choate, from London is assigned to the pending negotiations for a new and satisfactory canal treaty with England. A synopsis of the salient features of the treaty, under formulation, represents it in terms that must certainly prove satisfactory to the President and to Congress. It is hard to see if the forecast be correct, what further concessions England could make after abrogating the Clayton-Bulwer treaty, and acknowledging our right to build, own, control and protect the Canal. Senator Morgan, the canal champion in the Senate, is sure the treaty will be promptly ratified.

The reports of Cabinet changes will not down. Secretary Root has returned to the city with his family and declares that he has settled down for the winter and has no intention of resigning. Secretary Hay refuses to say anything except that he has not handed in his resignation up to this time. That he will do so as soon as the Hay-Poincote treaty is ratified is not doubted, and that Senator Lodge will succeed him is also confidently expected. Secretary Gage, whose declaration before the Banker's Convention, that he believes in the retirement of the greenbacks and the extension of the power of the national banks, is regarded as unfortunate, is expected to resign soon after Congress assembles. Assistant Secretary of the Navy, Hackett, has stated his intention to resign, and Judge Charles H. Darling, of Bonnington, Vt., will succeed him.

The President goes to Yale University this week, where he will be invested with the honors of a Doctor of Laws. It is probable also that Harvard, his alma mater, will follow with similar honors next summer.

THE NEWS FROM ALL THE WORLD

DOMESTIC

Speaking before the national convention of bankers in Milwaukee Secretary Gage commended a suggestion for one big central bank, with all the others as subsidiaries, and for the abandonment of the subtreasury.

President Roosevelt is engaged in writing his first message to congress. Every phase of national life will be considered by him.

The Schley case of inquiry heard the testimony of five officers of the Brooklyn, all the witnesses speaking in high terms of the admiral's courage and capability.

Citizens at Howell, Ind., fought off five robbers attempting to loot a store, shooting three of them, one fatally.

The Episcopal conference at St. Louis deferred action on the question of a change in name for three years.

The estimates of the navy for the fiscal year ending June 30, 1903, amount to \$98,910,088, against \$77,924,335 approved for the current year.

The annual report of the commissioner of education above for the year ended July 1, 1900, 17,050,710 pupils attended schools in the United States, an increase of 235,348 over the previous year.

William Gregory, of Wickford, has been nominated for governor by the Republicans of Rhode Island.

The headquarters of the national department of criminal identification are to be moved from Chicago to Washington.

The American Bankers' association ended its convention in Milwaukee after starting a movement for a reform of the banking system and electing as president Myron T. Herrick, of Cleveland, O.

The steamship St. Paul, chartered at Seattle with \$1,500,000 from R. C. McDaniel, Robert Huff and Dr. R. C. McDaniel, both prominent men, were fatally shot in a revolver duel at Wells, W. Va.

A new Iowa corporation has been organized in Burlington to take absolute control of and merge the Burlington, Great Northern and Northern Pacific roads, the properties to be bonded at \$750,000,000.

The triennial Episcopal convention adjourned in San Francisco to meet in Boston in 1904. The pastoral letter sounds a warning against the alarming growth of atheism and political corruption.

George Armitage, a messenger for the New Amsterdam bank in New York city, disappeared with \$200,000 in money and checks of the bank.

The entertainment of Booker T. Washington at the white house by President Roosevelt has aroused the indignation of aristocratic southern families.

Citizens who desire that Oklahoma and Indian territory be united to the union as a state will hold a convention at Muskogee, I. T., on November 14.

Assistant Postmaster General Dettow has ordered the establishment of a post office to be named "McKinley" in Franklin county, Washington.

The names of 2,205 students are enrolled for the autumn quarter at the University of Chicago.

Joseph E. Smith has been elected president of the Mormon church to succeed the late Lorenzo Snow.

The board of governors of the national bureau of identification at a meeting in Washington adopted a recommendation to be urged on congress for legislation looking to the suppression of anarchy.

Demagogues purporting to come from the United Irish League and containing threats against King Edward have been received by a Dublin judge.

The exchange in the leading clearing houses in the United States during the seven days ended on the 18th aggregated \$2,142,084,472, against \$2,061,667,495 the previous week. The increase compared with the corresponding week of last year was 56.2.

There were 192 business failures in the United States in the seven days ended on the 18th, against 211 the week previous and 223 the corresponding period of last year.

A new independent steel company has been organized in Pittsburg with a capital of \$3,000,000.

During the year just ended the business of printing and engraving turned over to the post office department \$2,550,000 postage stamps.

The National bank of Boyertown, Pa., has closed its doors on account of the disappearance of the cashier.

Frank W. Baker, assistant secretary of the navy, with \$100,000, and the assistant secretary Charles H. Darlington, with \$50,000, were the only two men in the navy who were not killed.

R. G. Don & Co.'s review of trade says that business this year will exceed all previous years.

Two employees of the Merchants' national bank of Lowell, Mass., disappeared after embezzling an amount that may reach \$100,000.

The department of state denied that the United States had offered to arbitrate between Venezuela and Colombia.

Gen. Col. William Amun, now in the Philippines, is to succeed Col. Van Horn at Fort Sheridan, Ill.

Anarchists are said to have threatened in letters received at Potosky, Mich., to kill 100 society women if Colozog is executed.

Col. Broderick of rough riders, has been appointed governor of Arizona.

Dollie Richards, who was kidnapped in the city of New York, is to be returned to her parents. The woman abductor in Chicago confessed.

The first monument erected at Valley Forge in memory of the revolutionary soldiers who died there during the winter of 1777-78 was unveiled.

Yale university began the celebration in memory of the centennial anniversary of the founding of Yale college in New Haven, Conn.

Fire destroyed the New England building at Pan-American exposition in Buffalo.

At Barborville, Ky., James Meridy was divorced from his thirteenth wife and married his fourteenth one hour later.

Address by Gen. C. C. Andrews, Chief (Forest) Fire Warden of Minnesota.

Forestry is the raising of trees for profit rather than for ornament. It is a great economy for us here in Minnesota because the pine has its home here and will flourish on land that is unfit for cultivation.

Let us suppose that on a 1,000 acre tract of land, too hilly, too rocky or too sandy for farming, a beginning was made eighty years ago to plant it with pine. The first year 20 acres were planted and every succeeding year 20 acres were planted. This year completes the rotation and cutting can now begin with the 20 acres first planted.

When in your travels you see poor soil that is lying idle, remember that if forested it would yield a good income. In the 3,000,000 acres of waste land in Minnesota were now a normal pine forest its annual growth would be 600,000,000 feet of the net value standing in the woods of \$2,400,000.

Baden, from 240,000 acres of state forest derives a net annual revenue of \$667,000; Saxony, from 432,000 acres of state forest derives a net annual revenue of \$2,000,000; Prussia, from 6,000,000 acres of state forest derives a net annual revenue of \$9,000,000; mostly non-agricultural land in each case.

PRINCESS TO MARRY.

Victoria, Daughter of King Edward, Will Soon Be Betrothed by Her Parents.

The formal announcement of the betrothal of Princess Victoria, daughter of King Edward and Queen Alexandra, will soon be made, but the name of the favored one has not been made public. Their majesties have long been anxious for the marriage of the princess, and have not been slow in encouraging one after another of eligible European princes who have sought her hand.

Princess Victoria, however, has never given encouragement to any of her royal suitors. English princesses have always married at an early age, and the reluctance of Victoria to enter into wedlock has been considered unaccountable. More than once there has been suspicion that her royal highness had given her heart to the keeping of some one out of the blood royal, but there has never been confirmation of this suspicion. She has always been somewhat eccentric and original, in this respect resembling her aunt, Princess Louise, whose mother, Queen Victoria, had no little trouble in breaking up her love affair with a young clergyman. Suitors for Victoria's hand were many before her grandmother died, and they have increased in number since her father ascended the throne.

It is now known that a betrothal heretofore has been prevented by the peculiar ideas of the marriage relation held by Princess Victoria. Another reason has also been advanced. The princess is said to be a victim of epilepsy. The betrothal is expected to reveal a most romantic love story.

INCREASED PENSION ROLL.

Over 2,000 Names Added to Uncle Sam's List of Soldiers Entitled to Governmental Aid.

During the fiscal year just ended the net increase in the number of names on the government pension rolls was nearly 2,000. The exact number now on the rolls cannot be ascertained until the various pension agencies send in their reports, but the officials of the pension office estimate the grand total at 606,000. During the year 41,561 original pensions were issued, of which 25,821 were to the soldiers and 21,091 to widows, minors and orphans. There were restored to the rolls 4,871 names, making a total of 46,432 names added to the rolls during the 12 months. The number of increases, restorations, etc., was 60,043, making the total number of certificates 109,555, which was an increase of 4,964 over the number issued in the previous year.

The number of claims pending on May 31, when the last inventory was taken, was 11,409, being a reduction of 27,869 compared with the number pending on June 30, 1907.


