Wilke's Island Resort

In the fall of 1905 Joseph Wilke bought property at the head of Pokegama Lake from W. A. Hayden. Mr. Wilke had plans to turn his land into a resort. As the lumbering business moved out of the area, the waterways became less clogged with logs. The public was quick to claim the water for the pursuit of pleasure.

ANOTHER SUMMER RESORT

The Island at the Head of Pokegama Lake
to be Converted into a Park—Cottages and Pavilion to Be Built.

Joseph Wilke has purchased the W. A. Hayden island and will clear it of underbrush and build cottages.

He will have a gasolene launch to take patrons from the island to this place. Among other improvements he will put up an addition to the Hayden house 24x40 feet, two stories high, and will in the near future build a pavilion and institute a genuine summer resort. Mr. Wilke has already commenced clearing the island and will immediately commence the erection of the addition contemplated. The island is one of the finest places on the road for a summer resort, and Mr. Wilke informs us that he will spare neither time, labor nor money in making the garden spot of Pokegama one of the best places in the state in which to spend the summer. The island is situated at the head of Lake Pokegama, and can be reached easily by team or boat from this place, as a good road runs to within about a mile of the place, and Mr. Wilke says he will have that fixed up so that there will be a good road directly to the summer resort.

W. A. Hayden was up from St. Paul this week on business. He has sold practically all of his property at the head of Pokegama lake, only reserving about two acres of ground on the point opposite the Fritzen sanatorium. The deal was closed yesterday whereby Jos. Wilkes, of St. Paul, came into possession of about 56 acres for which he paid \$2,000. Mr. Wilkes intends fitting up his newly acquired property as a summer resort and picnic ground. Wednesday Mr. Hayden disposed of two acres of land to Judge Loren W. Collins for a compensation of \$380. Judge Collins will erect a cottage on the picturesque lakeside where he will make his home during the summer months.

Ed Rebholz, who is camping with his brother Peter, on the Hayden Island, met with quite a serious accident Monday night while going from the mainland to the island he stumbled and fell striking on his thumb causing a green fracture. He walked down arriving here at one o'clock, and saw Dr. Barnum who attended to the injured thumb and Ed. will soon be as well as ever.

Joseph Wilke wasted no time getting construction started. He stayed at Indian Island and supervised the construction. His wife made occasional visits from St. Paul.

Launch "Pokegama."

One of the finest gasoline launches on the lake and river is the "Pokegama," built by Mr. Dingle, the St. Paul boat builder, and the engine built by Mr. Mooney, of the Capitol Engine Works, of the same city, for Jos. Wilke, proprietor of the Island Hotel and Summer Resort at Pokegama lake. The launch is 28 $\frac{1}{2}$ feet long, and will carry about fifteen passengers. The engine is an eight horse power and will drive the boat through the water at the rate of about nine miles an hour. The launch will be used for transporting the patrons of the Hotel to and from Pine City.


By the end of September the resort had quieted down enough that Joseph could go to St. Paul for a visit with his former co-workers.


The grand opening for the season was set for June 8, 1907. A crowd was expected so special provisions were made.

Fritzen's steamer "Fritz" will be in commission, the barge has been chartered and a fleet of launches will furnish transportation to and from the resort, so the transportation facilities will be ample. Mr. Wilke and assistants have made splendid provision for the entertainment of a large crowd and a banner attendance is anticipated. Everybody is invited to the grand opening. Boats will leave the dock tomorrow afternoon and evening, and boats will leave Wilke's in good season for the return trip.

Fritzens, a neighboring resort, ran a steamboat between Pine City and Pokegama Lake. They ran a special schedule for Wilke's opening. Stumne's orchestra played for the dance.

He stated that he expects to go to Ireland next fall to do some "real" fishing. The gentlemen were delighted with their sport at the lake and will go there again.

Small Boys Capture Big Fish.

Last Tuesday two sons of Iver Stumne had quite a thrilling experience while fishing from a small hunting boat eight or ten feet from the shore in about four feet of water. The little fellows, who were aged respectively four and five years, felt a tug on the line and they started for the middle of the lake. After towing the boat and boys for a half a mile the fish they had hooked became exhausted and came to the surface. The plucky little fellows reached over the side of the boat and got him by the gills but were unable to pull him into the boat. The order was then reversed and the boys started for the shore towing their prize. When nearly to the shore they were met by Dr. Healey, who was an eye-witness, and went out to help the boys. The combined strength of the three was not sufficient to lift the fish into the boat, which proved to be a 40 pound sturgeon. The fish furnished a dinner for the guests at Wilke's hotel Wednesday.

Committed Suicide.

Last Saturday forebreakfast Messrs. Paul Martin and Jas. Nugent underwent an experience at Pokegama lake that they would not care to have repeated on a seething sizzling sea. The gentlemen are natives of St. Paul—at least they exercise the rights of their citizenship at that place—and are not accustomed to the wildly ridiculous pranks of some species of aquatics at the lake. The gentlemen are guests at the Wilke resort and had been plotting to do an unusual stunt of fishing for some time past when Sunday morning they waxed restless and tossed themselves out of their dream-dens and simultaneously shot down to the water's edge from whence they rowed in 6-8 time to a fishing hole. They were rowing about and rather enjoying the novelty of the fore breakfast atmosphere when suddenly Paul let a yip out of him that for tone and action would give any one outside of a lunatic observatory a feeling of misplaced confidence. After they had exhausted their repertoire of telling how all big fish are caught they acknowledged that their friend from the deep (it weighed 19 pounds) had voluntarily jumped into their boat, possibly thinking at the time that it had struck a millionaire angle worm joint. Ed's many friends will be glad to hear such a favorable report from him.

EDWARD REBHOLTZ.

On last Saturday morning the sad news was circulated that Edward Rebholz, only son of Mrs. Joseph Wilke, of the Island Hotel and Summer Resort at Pokegama lake, had died at a hospital in St. Paul Friday evening at about 9 o'clock of consumption.

Ed has been a sufferer with that dreadful disease for the past four or five years. Four years ago he camped out on Pokegama lake during the entire summer, and when leaving in the fall felt fine, but during the winter went to the city and worked for the Golden Rule Co., when he returned in the spring he was away down in health again, but during the summer he got to feeling fine every year since he has done the same. Last fall he went to the city and during the winter was taken to the hospital where he died.

Ed. was a young man that made friends with all he came in contact with and will be greatly missed by the visitors at the popular resort at Pokegama lake.

The funeral was held in St. Paul Monday morning at 9 o'clock.

The Pioneer extends its sympathy to the bereaved ones.



The next reference in our files to the Wilke Resort is from 1923 when the resort is being sold. It is clear that there has been at least one owner since the Wilkes. The 1920 census confirms that Nick Taugner managed the resort for at least 3 years.
